

TERMS AND CONDITIONS

Correct use of the system (Rules of Ethics)

By registering in the ERMIS-F service (portal) you accept the terms of correct use and availability of information:

- Do not publish false events
- Do not publish photos, images or drawings with offensive content.
- Do not use abusive language and avoid using concepts or words that
- offend
- Do not publish personal comments to other members of the ERMIS-F community
- Do not publish offensive content or extreme posts
- Do not include links whose validity cannot be verified.

In the event that system administrators detect or are notified of a deviation from the code of conduct, they have the right to delete the material that has been made public/posted, as well as the exclusive right to exclude/delete the user from the ERMIS-F community.

How we collect the information you share (upload) on the portal

You provide all the information you wish to share with other users of the system directly and voluntarily. We post and process the information you upload to our portal when you:


- You share an event in the crowdsourcing application

Who are we

ERMIS-F is a European project (Action) that is part of the **Interreg V-A Cooperation Program** "**Greece - Cyprus 2014-2020**", under the priority axis "**Improving joint risk management against natural, technological and humanitarian disasters**" and co-financed by the European Union (ERDF) and from national funds of Greece and Cyprus.

ERMIS-F develops, in its three regions of application (**Cyprus, Crete and North Aegean**), a system of **information, prevention, forecasting and management of natural disasters with a focus on floods**. Using available digital mapping information and with the help of modern computing tools and models, it transforms the theoretical potential for specialists into a practical public service for all, freely accessible.

Personal Data

At ERMIS-F we are committed to the protection of personal data in accordance with the EU <u>General Data Protection Regulation</u>. Your personal data will therefore be governed by the above Regulation. If you have any questions about the processing of your personal data, either about accessing or correcting this data, you can send your request to <u>info@ermis-f.eu</u>.

Although you can browse through the ERMIS-F website without giving any information about yourself, we do require certain personal information in order to grant you access to some parts of our portal. We treat this data in accordance with our Personal Data Protection Policy.

Personal data we collect

When you register to become a member of the ERMIS-F network or when you subscribe to our newsletter, we store very limited personal data in our system. The following information is entered only in the portal database: name, surname, e-mail, and optionally the name of the organization you belong to. Absolutely no information about the members of the service is made public. In our various applications, only the username (which you have selected) is visible to other users. Only you can see all the details of your profile.

How we collect your personal data

You directly provide us with all the data we store. We collect and process data when you:

- Register online on the ERMIS-F web portal;
- A questionnaire is completed voluntarily or we are given your opinion on some of our applications via mail;
- When using or viewing our portal through the cookies of your browser. See the cookies section below for a detailed description.

How we collect the information you share (upload) on the portal

How personal data is stored and used

All the information we collect is stored securely to provide the user with:

- Access to the functions and applications of the ERMIS-F service; in case of new features, our users will receive an update.
- Access to ERMIS-F events. Event participants will receive relevant e-mailings.
- Monthly newsletters for subscribers.
- Other targeted mailings about our services.

ERMIS-F does not copy or modify your personal information in any way and uses it solely for the purposes of the ERMIS-F portal and for newsletters. ERMIS-F will not disclose your personal information to third parties. We will not disclose your personal information for any advertising purposes.

All data are collected from the online "User Profile" form or from other parts of our applications, and are stored securely our system's database. We take all the necessary measures for data security against possible misuse or unauthorized access. The data is stored in a high security server with regular backups. All personal passwords are encrypted.

How to access and modify personal data

You can access all the data you have disclosed to us, at any time, to verify its accuracy, and if necessary to correct it. To do this, please log in to your profile and correct anything you deem necessary.

You can always delete your profile, if you decide to do so. This can be done through one of the applications of our portal (Geoportal, Crowdsourcing, Social Network, Knowledge Base etc.). If you have any difficulty in correcting or deleting your profile, contact us at info@ermis-f.eu.

There is also the option to stop receiving our newsletters (you must have requested to receive them), and all our emails have the "unsubscribe" option.

Privacy Policy of other websites

The ERMIS-F portal contains links to other websites. Our privacy policy applies only to our website/portal. If you click on a link that redirects to another website, please also read their privacy policy. When you are transferred to another website, your personal data is not transferred in any case.

Contact the ERMIS-F website

The ERMIS-F website has the "Contact Us" option, which activates your email software and invites you to send your comments to a specific email box. If you have questions about the processing of your email and related personal information, do not hesitate to include them in your message.

Cookies

Our cookies, and how we use them:

If you create an account with us (by registering in the ERMIS-F portal), we will use cookies for the registration process and for the general management of the functions related to it. Cookies only retain the information necessary to allow the smooth navigation of the application, e.g. selected language and logged-in user information.

These cookies are usually deleted when you log out, however in some cases they may remain so that your browser remembers your preferences after you log out.

We use cookies when you are logged in so that the system can remember that you are logged in. This prevents you from having to sign in every time you visit a new page. These cookies are usually deleted when you log out, to ensure that only you can access locked features and data when logged in.

Our portal offers newsletter or email subscription services, and cookies can be used to remind the system that you are already registered and whether certain newsletters/mail only apply to subscribers or users who have stopped subscribing to them.

Disabling cookies

You can disable the installation of cookies by changing your browser settings (see your browser help instructions for this). Be aware, however, that disabling cookies will affect the functionality of the portal, as well as many other websites you visit. Disabling cookies will result in the deactivation of some functions and features of the portal. Therefore it is recommended that you do not disable **cookies**.
